Revised Pension Rules, 1950 and the New Family Pension Scheme, 1964 -Exercising of option for -

GOVERNMENT, RESOLUTION

In accordance with rule 9 of the Maharashtra Zilla Parishads District Services Rules, 1968, all allocated employees including the employees of the former District Local Boards transferred to Zilla Parishads are entitled to exercise option to be governed as respects pension etc. either by the provisions of these Rules or by rules etc. regarding pension etc. applicable to them immediately before the dates of transfer. The employees of ex-District Local Boards transferred to Zilla Parishads have thus a right to elect to be governed by the pension rules of the ex-District Local Boards. Some of the former District Local Boards bad adopted for their employees Revised Pension Rules. 1950, contained in the Bombey/Civil Services Rules, as amended from time to time. Such employees transferred from the ex-District Local Boards to the Zilla Parishads who, under rule 9, elect to be governed by the pension rules of the ex-District Local Boards ond who are governed by the Revised Pension Rules, 1960 as amended from time to time are entitled to the benefits of pension as contained in Government Resolution, Finance Department No. Pan-1063/2639-X, dated the 22nd January 1964 and the Family Pension Scheme, 1964 contained in Covernment Resolution, Finance Department No. PEN-1464/3/84-X doted the 8th May 1954 rend with Covernmen Resolution, Finance Department No. PEN-1466,9/68.X. dated the 25th March 1966 and Government Resolution, Finance Department No.PEN-1486/162/66-X dated the 3rd January 1967. The employees of such ex-District Local Boards as were in scrylce of Zilla Parishads on 31st December 1963 and were governed by the Revised Pension Rules, 1950, wholly or partially, would be eligible to apt for the "Family Pension Screme, 1964". Government is therefore pleased to direct that such of the explicit Local Board employees as were in service of the Zilla Parishads on the 31st December 1968 and are subject to Revised Pension Rules, 1950, wholly or partially, as sontained in the Bomboy Civil Service Rules, as amended from time to time as a result of their exercising an option for the persion rules of the Ex-District Local Boards should be permitted to exercise their option for the "New Pamily Pension Scheme 1084" within the period of option presented under the Inharashtro Z.lla Parishads District Services Rules. 1968.

2. The Chief Executive Officers of Talia Parisheds are requested to take steps to bring the exitents of this result to the notice of all explished Local Local manipless as we in the service of their Zilla Parisheds on the Sist December 1963 (including those who have since relied from service of the Zilla Parisheds).

- (111) the persons who fail to exercise option within the stipulated period will be deemed to have cleated the new Scheme of Pamily Pension.
