GOVERNMENT RESOLUTION

In accordance with rule 9 of the Maharashtra Zilla Parishads District Services Rules, 1968, all allocated employees including the employees of the former District Local Boards transferred to Zilla Parishads are entitled to exercise option to be governed as respects pension etc. either by the provisions of these Rules or by rules etc. regarding pension etc. applicable to them immediately before the dates of transfer. The employees of ex-District Local Boards transferred to Zilla Parishads have thus a right to elect to be governed by the pension rules of the ex-District Local Boards. Some of the former District Local Boards had adopted for their employees Revised Pension Rules, 1950, contained in the Bombay Civil Services Rules, as amended from time to time. Such employees transferred from the ex-District Local Boards to the Zilla Parishads who, under rule 9, elect to be governed by the pension rules of the ex-District Local Boards and who are governed by the Revised Pension Rules, 1950 as amended from time to time are entitled to the benefits of pension as contained in Government Resolution, Finance Department No. PEN-1063/2639-X, dated the 22nd January 1964 and the Family Pension Scheme, 1964 contained in Government Resolution, Finance Department No. PEN-1464/3/64-X dated the 8th May 1964 read with Government Resolution, Finance Department No. PEN-1466/9/65-X, dated the 25th March 1966 and Government Resolution, Finance Department No. PEN-1466/162/66-X dated the 3rd January 1967. The employees of such ex-District Local Boards as were in service of Zilla Parishads on 31st December 1963 and were governed by the Revised Pension Rules, 1950, wholly or partially, would be eligible to opt for the "Family Pension Scheme, 1964". Government is therefore pleased to direct that such of the ex-District Local Board employees as were in service of the Zilla Parishads on the 31st December 1963 and are subject to Revised Pension Rules, 1950, wholly or partially, as contained in the Bombay Civil Services Rules, as amended from time to time as a result of their exercising an option for the pension rules of the Ex-District Local Boards should be permitted to exercise their option for the "New Family Pension Scheme 1964" within the period of option prescribed under the Maharashtra Zilla Parishads District Services Rules, 1968.

2. The Chief Executive Officers of Zilla Parishads are requested to take steps to bring the contents of this resolution to the notice of all ex-District Local Board employees as were in the service of their Zilla Parishads on the 31st December 1963 (including those who have since retired from service of the Zilla Parishads).

3. It should also be brought to the notice of the employees that -

- (i) the option once exercised is final and cannot be rescinded;
- (ii) if the option has already been exercised, no fresh option will be allowed; and
- (iii) the persons who fail to exercise option within the stipulated period will be deemed to have elected the new Scheme of Family Pension.
