Travelling Allowance to
Government servants on

READ:- Government Resolution, Finance Department, No. TRA-1064/1046/XVIII,
dated the 16th July 1966.

RESOLUTION:- According to the orders contained in paragraph 3(viii) of the Government Resolution, Finance Department, No. TRA-1064/1046/XVIII, dated the 16th July 1966, the amount of Travelling Allowance admissible to a Government servant on retirement is to be reduced by the amount reimbursed to him on account of leave travel concession for the forward journey, if availed of by him during one year preceding the date of retirement or commencement of leave preparatory to retirement. A question has arisen whether the deduction should be made from the entire retirement travelling allowance (i.e. the cost of journey and charges for transportation of personal effects) or whether the adjustment should be made only against the cost of rail fares. Government is pleased to decide that the adjustment of leave travel concession in such cases shall be made only against the cost of fares admissible to the retired Government servant for self and/or family under the above orders and that the cost of transport of personal effects may be allowed to the retiring Government servant in full, as admissible.

2. These orders take effect from the date of issue and will apply to journeys commencing on or after that date. Past cases which have already been decided otherwise will not be reopened; but pending cases may be settled on the basis of these orders.
