**C I R C U L A R**

The Administrative Reorganisation Committee has recommended to Government that in order to maintain a proper balance between direct recruitment and promotion to posts in Class-I and Class-II services, where the proportion of direct recruits prescribed at present is less than 50%, it should be raised to that level. It has also recommended that in the case of those Class-I and Class-II services for which no proportion of direct recruits and promotees has been fixed at present, it should be laid down that 50% of posts should be filled by direct recruitment. Government has accepted these recommendation and is accordingly pleased to direct that all departments of the secretariat should take a review of the existing ratio prescribed for direct recruitment on promotion prescribed for the posts in Class-I and Class-II services under their administrative control and to amend, wherever necessary, the existing providence in recruitment rules in consultation with the General Administration Department and the Maharashtra Public Service Commission, so as to conform to the recommendation of the Administrative Reorganisation Committee accepted by Government.

2. Another recommendation of the Administrative Reorganisations Committee is that, it is necessary to make provision for direct recruitment at the subordinate levels of every departmental hierarchy and in particular to provide for direct recruitment of graduates in the offices of the Heads of Departments and to the posts of Aval Karkuns in the Revenue Administration. The proportion of such direct recruitment at subordinate levels may be fixed at 25%. Government has accepted this recommendation also and is accordingly pleased to direct that all Departments of the Secretariat should take a necessary steps to examine the various subordinate cadres in the offices of the Heads of Departments under their control and make a provision in the relevant recruitment rules for direct recruitment of graduates at suitable levels in consultation with General Administration Department.
