Subject: Installation of Statues of renowned personalities
Indiscriminately and without the permission of the
competent authorities.

Sir,

As you are aware that the Government of India and various
fora have from time to time stressed on the need for the state
Governments to take steps to ensure proper law and order in the country.
It has come to notice of the Government that some vested people/social group
are encroaching or try to encroach the land belonging to the Government
/local body and Gram Sabha by erecting statues of renowned personalities.
Such incidents are increasing gradually. Instances have also come to the
notice that in certain areas even land for public use or land earmarked to be
allotted to landless people is also occupied by some interested persons
unauthorisedly resulting social unrest and law and order situation, peace
and tranquility in the surrounding areas are affected adversely. Also, the
poor villagers and general public are deprived of their rights and have to
face a lot of inconvenience.

In the above context, State Governments are, therefore, advised
to take necessary steps and issue instructions that no person or a group of
persons should erect any statue of renowned personalities indiscriminately
on the land owned by Government /local body and Gram Sabha without
obtaining prior permission of the competent district authorities. It may be
ensured that the instructions issued in this regard are brought to the notice
of all concerned authorities and should be observed scrupulously.
