According to the Orders contained in Government Resolution, General Administration Department, No. BCC-1064-III-J, dated 9th June 1965, 13% of vacancies occurring in each of the services and cadres under the State Government which are filled by direct recruitment are required to be reserved for Scheduled Castes and Scheduled Castes converts to Buddhism. It has been brought to the notice of Government that while advertising the posts, reservation is shown for Scheduled Castes only and not Scheduled Castes and Scheduled Castes converts to Buddhism, as required under orders referred to above. The Scheduled Castes converts to Buddhism may not apply for such posts, being under the impression that they are excluded from the aforesaid reserved vacancies. Thus, the present manner of advertisement detracts from fulfilment of the object of the Government orders.

2. With a view to ensuring that candidates belonging to Scheduled Castes and Scheduled Castes converts to Buddhism are able to utilise fully the representation which has been specifically prescribed for them, all Departments of the Mantralaya and all Heads of Departments/Offices are informed that they should indicate reservation for Scheduled Castes and Scheduled Castes converts to Buddhism while advertising the vacancies in newspapers or sending requisitions for the Maharashtra Public Service Commission, State Selection Board, Employment Exchanges and Social Welfare Officers.
