CIRCULAR OF GOVERNMENT

In Government Circular, General Administration Department No. BCC-1072/J, dated the 1st January 1975, the Secretariat Departments and the Heads of Departments/Offices had been requested not to regulate promotions in accordance with the orders issued in Government Resolution, General Administration Department No. BCC-1072/J, dated the 23rd May 1974, until further orders, in view of the stay order given by the High Court in Special Civil Application No. 2864 of 1974, G.A. Borikar and others Vs. the State of Maharashtra.

The High Court has now passed orders modifying the injunction so as to be applicable to promotions of Aval Karkuns to the post of Naib Tahsildars in the Revenue Department and in the Aurangabad Division only. The Secretariat Departments and Heads of Departments/Offices are, therefore, now requested to implement the orders issued in Government Resolution, General Administration Department No. BCC-1072/J, dated the 23rd May 1974, except in the case of promotions of Aval Karkuns to the post of Naib Tahsildars in the Revenue Department in the Aurangabad Division.

If any promotions other than those of Aval Karkuns to the post of Naib Tahsildars in the Revenue Department in the Aurangabad Division have been effected during the period from the 1st January 1975 to the date of issue of this Circular on the basis of the practice obtaining prior to issue of the orders in Government Resolution, General Administration Department No. BCC-1072/J, dated the 23rd May 1974, they should
