In the Government Circular, dated 21st January, 1975, referred to above Secretariat Departments and Heads of Departments/Offices had been requested to implement the orders issued in the Government Resolution, General Administration Department No. BCC.1072-J, dated 23rd May, 1974 except in the case of promotion of Awal Karkuns to the posts of Naib Tahsildars in the Revenue Department in the Aurangabad Division. These instructions were issued in view of the interim injunction which was granted by the High Court, Bombay in the Special Civil Application No. 2864 of 1974 filed by Shri G.A. Borikar and others V/S. State, restraining the promotion of Awal Karkuns to the posts of Naib Tahsildars in the Revenue Department in the Aurangabad Division only.

2. The aforesaid Special Civil Application No. 2864 of 1974 filed by Shri Borikar and others has been rejected by the High Court on 15th June, 1978 resulting in vacation of the interim injunction which was in force till then. The orders issued in Government Resolution No. BCC-1072-J, dated 23rd May, 1974 regarding reservation at the stage of promotion for three sections of the Backward Classes in Government service can now be implemented without any exception.

3. Government is, therefore, pleased to order that the above mentioned Circular dated 21st January, 1975 holding in abeyance the implementation of the Government Resolution dated 23rd May, 1974, with respect to the promotion of Awal Karkuns to the post of Naib Tahsildar in Aurangabad Division should be treated as withdrawn.
