No. RTR-1094/CR.No.9/94/XII.- In exercise of the powers conferred by the proviso to article 309 of Constitution of India and in supersession of all the existing rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the posts in Group 'D' service mentioned in the Schedule appended hereto, in the Departments of the Government of Maharashtra, namely :-

1. These rules may be called the Maharashtra Group D posts in Government Departments (Recruitment) Rules, 1995.
2. In these rules, unless the context requires otherwise, -

(a) "Appointing Authority", in relation to the posts specified in the Schedule, means the authority competent to make appointment to those posts;

(b) "Department" means the Department specified in the First Schedule to the Maharashtra Government Rules of Business made under article 166 of the Constitution of India and includes the offices under its control;

(c) "Government" means the Government of Maharashtra;

(d) "Schedule" means the Schedule appended to these rules.

3. Appointment to the posts mentioned in Part 'A' of the Schedule shall be made by promotion of suitable persons, on the basis of seniority subject to fitness from amongst the persons holding the posts mentioned in Part 'A' of the Schedule and such of the persons holding the posts in Part 'C' of the Schedule, having not less than three years regular service in that post and possess the educational qualification prescribed for appointment by nomination under sub-clause (ii) of clause (c) of rule 6.

4. Appointment to the posts mentioned in Part 'B' of the Schedule shall be made either, -

(a) by promotion of suitable persons, on the basis of seniority subject to fitness, from amongst the persons holding the post mentioned in Part 'D' of the Schedule having not less than three years regular service in that post; or

(b) by transfer of suitable persons from amongst the persons holding the posts mentioned in Part 'C' of the Schedule and possessing the educational qualification prescribed for appointment by nomination under sub-clause (ii) of clause (c) of rule 6.

5. Appointment to the posts mentioned in Part 'C' of the Schedule shall be made by promotion of suitable persons, on the basis of seniority subject to fitness, from amongst the persons holding the posts mentioned in Part 'E' of the Schedule having not less than three years regular service in that post.

6. Appointment to the posts mentioned in Part 'D' of the Schedule shall be made either, -

- (a) by promotion of suitable persons, on the basis of seniority subject to fitness from amongst the persons holding the post mentioned in Part 'D' of the Schedule having not less than three years regular service in that post; or
- (b) by transfer of suitable persons from amongst the persons holding the posts mentioned in Part 'B' of the Schedule and possessing the educational qualifications prescribed for appointment by nomination in sub-clause (ii) of clause (c); or,
- (c) by nomination from amongst the candidates, who, -
 - (i) are not less than 18 years and not more than 30 years of age; and
 - (ii) have passed the fourth standard examination from a primary school recognised by the Government;

Provided that, the Appointing Authority may relax the upper age limit upto 45 years in favour of a candidate who is ex-serviceman and military pensioners.

7. Appointment to the post mentioned in Part 'E' of the Schedule shall be made by nomination from amongst the persons who are not less than 18 years and not more than 30 years of age;

Provided that the Appointing Authority may relax the upper age limit upto 45 years in favour of a candidate who is ex-serviceman and military pensioner.

8. Appointment to the post mentioned in Part 'F' of the Schedule shall be made by nomination from amongst the persons, who, -

(i) are not less than 15 years and more than 18 years of age; and

(ii) have passed the fourth standard examination from a Primary School recognised by the Government,

9. Notwithstanding anything contained in the foregoing rules, recruitment to any of the posts mentioned in the Schedule may, in special circumstances, be made in such manner as the Government may deem necessary and direct from time to time, by issue of special or general orders in this behalf.

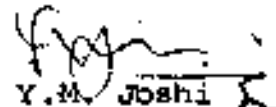
